Application supported by 2 veterinarians (one must be listed at least as Level 2 Official Veterinarian)

Accept the Permitted Treating Veterinarian Codex

Pass the Permitted Treating Veterinarian online course with examination

Pass the Permitted Treating Veterinarian online assessment every 3 years

#### Article 1101 **Permitted Treating Veterinarians**

- 1. Permitted Treating Veterinarians may assume the following roles:
- · Veterinary Control Officer;
- Treating Veterinarian (TV):
- Team Veterinarian:
- · Athlete's Private Veterinarian (APV); and Holding Box Veterinarian.
- 2. PTVs must have adequate professional indemnity insurance

Minimum 3 years of equine veterinary experience

Recommended by the National Federation

#### Requirements

Level 1 Official Veterinarian

Minimum 5 years of equine veterinary experience

Archieve an English proficiency grade of B1 or higher

#### Education

Transfer Up Course

- First discipline: 3 FEI events with at least 2 different Level 3 or 4 Offical Veterinarians
- Every additional discipline: 1 FEI event with a Level 3 or 4 Official Veterinarian

CES Online Assessment every year

CES Maintenance Course every 3 years

Minimum 1 FEI event every 3 years



#### Requirements

Level 2 Official Veterinarian for minimum of 3 years + officiated minimum 10 FEI events

Level 2 Official Veterinarian for 9 consecutive years + minimum 6 FEI events

# Job Description Level 2-3-4 Official Veterinarian

# **During each Event**

- ✓ Ensure all horses are Fit to Compete
- ✓ Authorise and oversee the treatment of horses
- ✓ Support the Testing Veterinarian and carry out testing, where required
- ✓ Be present for the duration of the Event
- ✓ Liaise regularly with the Chief Steward

## After the Event

✓ Complete the Online Veterinary Report within 72 hours



# Job Description Level 2-3-4 Endurance Official Veterinarian

## **During each Event**

- ✓ Liaise with the President of the Ground Jury, the Chief Steward, the OC and other stakeholders
- ✓ Ensure all emergency protocols and preparations are in place
- ✓ Authorise treatment of horses
- ✓ Carry out EADCM testing where required
- ✓ Liaise regularly with the Chief Steward and President of the Endurance Veterinary
  Treating Commission
